ORDER

Consequent upon the approval by Hon'ble the Chief Justice, of the recommendations of Hon'ble Committee constituted for Compassionate Appointment, sanction is hereby accorded to the temporary appointment of the following candidates in Jammu Province in terms of J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22.02.1994:

- 3. Shri Dinesh Khajuria, Copyist/Junior Assistant in the Court of Munsiff, Hiranagar is transferred and posted as Civil Clerk/Junior Assistant in the same Court against available vacancy.

- i) The appointees are directed to join their place of postings within a period of 21 days from the date of issuance of this order;
- ii) The Presiding Officers before whom new appointees have to join are directed to get their all the testimoniols verified from the concerned authorities.
- iii) The new appointees shall give an undertaking in the shape of an affidavit duly attested by a Judicial MagIstrate 1st Class to the effect that in case adverse report about their character and antecedents is received from the Inspector General af Police, CID, Jammu & Kashmir to whom a reference shall be made by the concerned Presiding Officer, their appointment shall be deemed to be cancelled ab-Initio and she shall have no claim on her appointment.
- iv) The salary of the new appointee shall not be drawn and disbursed unless a satisfactory report in respect of (ii) & (iii) abave is received.
