Whereas, the petitioners through their counsel M/S Zaffar Law Associates, had filed writ petition bearing SWP No. 2727/2018 before this wing of Hon'ble High Court of Jammu and Kashmir in the year 2018, with the following prayers:

- a) Writ direction or order Agriculture Order No. 110/Estt of 2016 dated 30.05.2016 showing regularization of the petitioners as from 01.04.2015 instead of 01.04.2014 be quashed. Consequent thereto, by writ of mandamus official respondents be directed to show and treat regularization of the petitioners as Agriculture Extension Assistants as from 01.04.2014 i.e. the date when the private respondents have been regularized in terms of Order No. 281/Estt of 2014 dated 23.06.2014.
- b) That by a writ of mandamus respondents be directed to include the petitioners in the updated seniority list of Rehber-e-Zirat with effect from 01.04.2014 and to place the petitioners within the said list at appropriate places bases on the merit of the petitioners determined in terms of Government Order No. 378-Agri of 2013 dated 28.11.2013.
- c) That by writ of mandamus official respondents be directed to place the petitioners in the Pay Band of Rs. 9300-34800 with GP 4200 (pre-revised) with effect from 01.04.2014 and grant all consequential benefits thereto as will accrue to them consequent to their placement.

Whereas, Civil Miscellaneous application No. 7540/2019 (in SWP No.2727/2018), for amendment in the prayer clause of writ petition & CM No. 7541/2019 for restraining the respondents from making promotions to the post of Junior Agriculture Extension Officer, in the above titled case was listed before the Hon'ble Court on 20.12.2019.

Whereas on the aforesaid date, Mr. B. A. Dar, Learned Senior Additional Advocate General, has caused his appearance on behalf of official respondent Nos 1 to 3, and the Hon'ble Court was pleased to issue notice to rest of the respondents by way of publication in two leading newspapers having wide circulation in Jammu and Srinagar,

Now, therefore, in compliance to Hon'ble Court order dated 20.12.2019, the instant notice is hereby published calling upon the respondents except respondents 1 to 3, to appear either in person or through counsel or any authorized agent on 06.03.2020 at 10:30 AM before the Srinagar Wing of the Hon'ble Court.

Take notice, that in case of non-appearance, the matter will be determined in absence of the respondents and law will take its own course.
