- (iii) The selection of the candidate shall be made on the basis of cumulative grade value obtained in the written examination and viva voce test.
- (iv) Only those candidates who secure 70% or more marks shall be declared successful. The appointments to the post shall be made on vacancies available for the category (b) of Rule 5 on the basis of inter-se merit of successful candidates."
