- (a) All promotions are subject to the outcome of SLP(C) No. 13607-610 of 2016 titled Ashok Kumar and ors etc. etc. vs State of J&K and ors and in case the Hon'ble Supreme Court directs that the under graduate officials of the High Court staff shall be eligible for promotion to the next higher post in order of their seniority, in that event, the eligibility shall be determined on the basis of merit cum seniority and the undergraduate officials shall be considered for promotion, without disturbing their seniority which shall have the effect of reversion of some of the officials considered for promotion at this moment against those posts.
