Note 7: Special Bench(s), if any constituted in addition to the Roster Benches, shall be convened in second half of the Friday.

Note 8: If the listed matters related to personal liberties are not taken up for any reason in first half of the day in that event these matters shall be taken up by the concerned Benches at the beginning of the post lunchsession as per the convenience of the concerned roster bench.

Note 9: First ten cases in the list before the Bench(s) shall not be ordinarily adjourned.
