After examining the documents submitted by the vendors with their respective bids, a comparative statement showing compliance of eligibility conditions by each of the bidder is reflected in the annexure attached with this report. On the basis of comparative statement, all the bidders except M/S Writer Information were found to have complied with all the requisites of the eligibility criteria. M/S Writer Information was found not eligible as it has failed to submit physical copies of EMD as well as cost of the tender document till date. Hence all the bidders barring M/S Writer Information are declared to have passed the pre-qualification stage.

In view of the above, it is recommended that all the seven bidders who have been found eligible be called for live demonstration of the scanning, digitization, retrieval and workflow process as required under the tender document on the date to be notified separately.
