## TECHNICAL AND FINANCIAL EVALUATION OF BIDS

As per the tender document, a bidder had to submit the following documents along with its bid in order to participate in the bidding process:

- A. EMD of Rs 10,000.00 in the form of DD/CDR/Bank Guarantee in the name of Registrar General.
- B. Tender fee of Rs 500.00 by way of DD in the name of Registrar General.
- C. In case the bidder is registered with MSME/NSIC, copy of registration certificate.
- D. If the bidder is an OEM, then letter of incorporation and if the bidder is dealer, letter of authorisation from OEM.
- E. Details of the items offered and if the same comply with the specifications as sought in the tender document.
- F. Registration Certificate of sole proprietorship firm.
- G. Registration number of GST and Income Tax /PAN/TIN Certificates.

All the bidders have complied the above mentioned terms and conditions. It is pertinent to mention here that M/S Chessy Knowledge Quotient Pvt. Ltd Kolkata has sought exemption from payment of EMD and

tender fee and has submitted certificate of registration with MSME. In our tender document, it is mentioned that vendors registered with NSIC and MSME are exempted from payment of EMD and Tender Fee. On plain reading, the registration may be with either or both of the organisations and certificate from either of the two will entitle a bidder from exemption. Hence all the bidders above mentioned have qualified the technical evaluation.

The aggregate rates quoted by the bidders for 450 number of DSCs are reflected as under:
