#### Format of the test

#### (a) Steno-Typist

Candidates will be dictated a paragraph in English comprising 300 words in five minutes. The candidates shall take the dictation in shorthand and thereafter transcribe the same on Computer in 10 minutes.

#### (b) Junior Scale Stenographer

Candidates will be dictated a paragraph in English comprising 350 words in five minutes. The candidates shall take the dictation in shorthand and thereafter transcribe the same on Computer in 10 minutes.
