**CIRCULAR**

Applications are invited for filling up of the post of Registrar in the Armed Forces Tribunal, Regional Bench, Chandigarh on deputation basis initially for a period of one year extendable upto three years or on re-employment on contract basis for a period of one year from suitable candidates who fulfill the following eligibility conditions:-


2. The pay of the officer selected on deputation basis will be governed by DoP&T O.M. No. 6/8/2009-Estt(Pay-II) dated 17.06.2010, as amended from time to time.

3. The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications.

4. The maximum age limit for the re-employment on contract basis is 64 years. The pay of the officer on re-employment on contract basis will be fixed as per DoP&T OM No. 3/3/2016-Estt (Pay-II) dated 1.5.2017.

5. The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointments by promotion channel.
6. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other Government Organization or department shall not ordinarily exceed **three years**.
7. The application (s) in the prescribed Proforma (Annexure-I) of the eligible officer(s) who can be spared in the event of their selection may be forwarded to the Principal Registrar, Armed Forces Tribunal, Principal Bench, New Delhi by the Departments **latest by 10 November 2017 (Friday)** along with photo copies of the Annual Confidential Reports for the last five years of the candidates along with Vigilance Clearance Certificate..
8. The applicant (s) interested in applying, for the post of Registrar on re-employment on contract basis may send their application (s) directly to the Principal Registrar, Armed Forces Tribunal, Principal Bench, New Delhi – 110 066 by the aforesaid date along with all the relevant documents like PPO, Date of Birth Certificate, LLB Certificate, and Experience Certificate etc.
9. The applications received without supporting documents, photograph, unsigned and incomplete in any manner, shall be summarily rejected.
10. Those who have already applied with reference to this office Circular No 1 (64)/AFT/ PB/Adm-II dated 18<sup>th</sup> Jan 2017, need not apply afresh.
